A. CALL TO ORDER

The meeting of the Air Carrier Service – Marketing – Community Relations Committee was called to order at 1:02 PM. Director Miller. Director Pick and Executive Director La Pier were in attendance.

Review 3. Air Carrier Service Development Update

Executive Director La Pier provided an update on the current status of discussions with aha! Airlines about new service opportunities. He indicated he again thought a decision was imminent.

Executive Director La Pier provided a status update on discussions about a visit by a Canadian airline to Monterey. The effort to finalize and plan is being done jointly with the MCCVB and Visit Carmel. La Pier indicated that MCCVB had discussed this potential visit with the Economic Development Committee of the County as part of their overall effort to secure as much as \$300,000 in future funding for air service development.

Discussion 4. Local Marketing and Outreach Update

Executive Director La Pier reviewed with the committee the newly signed sponsorship agreement with Big Sur Marathon for both the Half Marathon and the full Marathon in 2023. Director Pick commented that the sponsorship was the subject of discussion at the Marathon Board meeting and that it had been warmly received. La Pier indicated the airport will again partner with United Airlines on this sponsorship as has been done in previous years.

Executive Director La Pier also discussed the sponsorship of an upcoming concert at Folktale Vineyards with KTOM radio. He indicated the radio station had provided more than 50 on-air radio advertisement opportunities as well as live on-air mentions about the show and the sponsorship by MRY. The sponsorship cost \$5,000 and is targeted at the Salinas market since KTOM is the #1 radio station in that market.

Discussion 5. Passenger Comments, Services and Amenities Update

The passenger comment card report was reviewed by the committee. Executive Director La Pier indicated he would refer a comment regarding rental car availability to Operations and Properties for discussions with the tenant.

Discussion 6. Community Noise Concerns Update

The noise concerns report was reviewed with the committee.
