D. REGULAR AGENDA – ACTION ITEMS

Review

 Resolution No. 1810, A Resolution Authorizing and Approving the Service Agreement between the Monterey Peninsula Airport District and William A. Thayer Construction Inc.

Executive Director La Pier reviewed Resolution No. 1810 with the Committee. He indicated that the property at 2801 Monterey Salinas Highway, Building A, had been recently treated for termites and that the damage done by the pests required that the wooden decks be replaced to return them to useable condition. The decks are cantilevered into the building and the repairs needed are more significant than just rebuilding the decks themselves. He stated that after the tenting and inspection, staff had worked with William Thayer Construction to develop a not to exceed cost estimate of \$193,170.00 to complete the work.

Discussion ensued regarding the grant process that allowed the airport to purchase the property and the inspection process that was accomplished during the acquisition. La Pier indicated replacement of the 40-year-old deck was going to be needed at some point. Director Cursio asked if a second bid had been secured. La Pier responded that he did not know but would address that with the project management team.

After some discussion, Director Miller indicated he could support the resolution. Director Cursio agreed.

Discussion 2. Leasing Activity Review

La Pier reviewed leasing activity with the committee including discussions with Del Monte Aviation regarding the potential lease buy back of the south side hangar area and the proposed sale of Sky Park Self Storage by the current owners.
