Review 1. Small Community Air Service Development Program (SCASDP) Grant Application

Executive Director La Pier presented the latest timetable for the application period and an update on the application preparation. He indicated that all contributors had been contacted regarding their feedback related to inclusion of United Airlines Denver service as a target market in the application along with American Airlines service to Dallas. To date, all contributors had agreed to support the inclusion of potential United service with the exception of Monterey County Convention and Visitors Bureau who will take up the matter at their November 15th Board meeting. La Pier indicated the initial feedback from MCCVB staff was positive.

Director Miller asked about the timeline for DOT consideration and award once the application period closed. La Pier indicated there is no specific timeline however past practice would indicate somewhere between 60 to 90 days before awards are announced. That timeline could change given the budget and staffing uncertainties in the Federal Government.

Executive Director La Pier indicated he would be in Washington, D.C. during the week of Thanksgiving and had a meeting scheduled with representatives from DOT to discuss the application process and how to better position our application for positive consideration.
