

**MONTEREY PENINSULA AIRPORT DISTRICT  
ORDINANCE NO. 931**

**AN ORDINANCE OF THE MONTEREY PENINSULA AIRPORT DISTRICT TO  
RECODIFY AND REPUBLISH THE ORDINANCES OF THE MONTEREY  
PENINSULA AIRPORT DISTRICT AND TO CAUSE THE RECODIFIED  
ORDINANCES TO BE PUBLISHED ON THE DISTRICT WEBSITE**

**NOW, THEREFORE**, the Board of Directors of the Monterey Peninsula Airport District DO ORDAIN as follows:

SECTION 1: Findings and Purpose. The Board finds and declares as follows:

A. WHEREAS, the Ordinances of the Monterey Peninsula Airport District ("MPAD") have been supplemented over the years with the passage of new ordinances, the repeal of some Ordinances by operation of law or by elimination and the Ordinances have not been recompiled or recodified in its entirety for several decades; and

B. WHEREAS, the Ordinances of MPAD are not currently located in a publicly accessible manner; and

C. WHEREAS, MPAD now desires to recodify, recompile and update the Ordinances into a modern, user-friendly format to aid MPAD staff, residents and other individuals and entities that wish to use and/or comply with the Ordinances; and

D. WHEREAS, the Ordinances of MPAD have been updated without changing any substantive provisions of the Code.

SECTION 2: Recodification of Ordinances - Summary. To provide certainty, clarity and transparency, the Ordinances of the Monterey Peninsula Airport District shall be recodified, republished, and posted on the District website, as outlined in this Ordinance.

SECTION 3: Validity of Prior Property Purchases and Property Transfers. Notwithstanding any repeal of an Ordinance authorizing the purchase, lease, sale or transfer of any real property right, all real property purchases, leases, sales, and transfers that occurred prior to the adoption of this Ordinance shall not be invalidated by the adoption of this Ordinance.

SECTION 4: Validity of Prior Agreements. Notwithstanding any repeal of an Ordinance authorizing an Agreement with another party, all Agreements with another party that were executed prior to the adoption of this Ordinance and which are still in effect shall not be invalidated by the adoption of this Ordinance.

SECTION 5: Recodification of Specific Ordinances. The following Ordinances, which are currently in effect, shall be recodified and shall remain in effect: 785, 830, 898, 909, 913, 916, 917, 918, 919, 920, 922, 923, 925, 928, 929, and 930. All other Ordinances previously approved and not listed here are repealed and of no further force or effect.

SECTION 6: Publication on Website. The recodified Ordinances of the Monterey Peninsula Airport District shall be published on the District's website to provide clarity and

to make it easier for members of the public to locate applicable laws, and to better understand and comply with the Ordinances.

SECTION 7: Severability. It is hereby declared to be the intention of the Board that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance is declared unconstitutional or without effect by any final judgment or decree of a court of competent jurisdiction, such judgment or decree shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance.

This ordinance shall take effect on the 30<sup>th</sup> day after its adoption.


