

ORDINANCE NO. 394

AN ORDINANCE CANCELLING SECTION IX OF ORDINANCE NO. 322 AND ESTABLISHING HOLIDAYS FOR OFFICERS AND EMPLOYEES OF THE MONTEREY PENINSULA AIRPORT DISTRICT

WHEREAS, Section IX of Ordinance No. 322 established the following District holidays:

First day of January (New Year's Day),  
Third Monday of February (Washington's Birthday),  
Third Monday of May (Memorial Day),  
Fourth day of July (Independence Day),  
First Monday of September (Labor Day),  
Fourth Monday of October (Veteran's Day),  
Fourth Thursday of November (Thanksgiving Day),  
Day following Thanksgiving Day,  
Twenty-fourth day of December (Christmas Eve),  
Twenty-fifth day of December (Christmas);

and,

WHEREAS, the Board of Directors of the Monterey Peninsula Airport District find it in the best interests of the public, the District, and District employees to establish and recognize Martin Luther King Day as a District holiday;

NOW, THEREFORE, the Board of Directors of the Monterey Peninsula Airport District do ordain as follows:

SECTION I:

Section IX of Ordinance No. 322 is hereby cancelled.

SECTION II:

All officers and employees shall be entitled to the following holidays:

First day of January (New Year's Day)  
Third Monday of January (Martin Luther King Day),  
Third Monday of February (President's Day),  
Third Monday of May (Memorial Day),  
Fourth Day of July (Independence Day),  
First Monday of September (Labor Day),  
Fourth Monday of October (Veteran's Day),  
Fourth Thursday of November (Thanksgiving Day),  
Day following Thanksgiving Day,  
Twenty-fourth day of December (Christmas Eve),  
Twenty-fifth day of December (Christmas Day)

It is the intent of this Ordinance that all officers and employees of the District not excluded below shall observe the eleven (11) holidays set forth above.

SECTION III:

This Ordinance only applies to those employees not covered by a contract of collective bargaining. Those employees shall

be bound by the terms of their agreement.
